

## COMPLIANCE STATEMENT Per- and Polyfluoroalkyl Substances (PFAS)

This sheet is to confirm that the product(s)/part number(s) referenced below do not contain any of the PFAS compounds\*, except any that are marked as "Contain" in the PFAS Compliance Status specifically:

\* PFAS compounds are defined as fluorinated substances that contain at least one fully fluorinated methyl or methylene carbon atom (without any H/Cl/Br/l atom attached to it), i.e., with a few noted exceptions, any chemical with at least a perfluorinated methyl group (-CF3) or a perfluorinated methylene group (-CF2-) is a PFAS". The "noted exceptions" refer to a carbon atom with a H/Cl/Br/l atom attached to it.

Several commonly used PFAS compounds are listed below, and more can be found in four reference lists of known PFAS compounds are provided for reference below; however, the request incorporates all PFAS compounds regardless of their presence on the provided reference lists.
